# Placement Rules and Regulations

Campus placement in the Vishveshwarya Group of Institutions is a facility provided for all eligible final-year students. All eligible students must appear in all companies coming for campus recruitment, till they get placed or else the candidate is strictly debarred from the entire placement season.



## Eligibility Criteria and Placement Registration

01

The job seeking candidate must be the pass out student of Diploma, Graduation or Post Graduation from Vishveshwarya Campus by the end of the academic year and is seeking employment.

02

Each student should register to the placement cell with a duly filled Registration form and submit the hard copy of the student-placement registration form to the placement officer along with their resume.

03

All students who wish to take part in the institute campus placements should take part in the soft skills program organized by the institute without missing a beat. Otherwise, their registration for placement will be cancelled.



## Resume-Student Placement Registration

01

Information regarding company visits will be provided through announcements and notice boards. Students are advised to check the details from time to time.

02

Students are expected to follow the Institute resume template available in the college for preparing their personal resumes.

03

Students have to always carry one folder with them containing a hardboard, attested mark sheets, certificates, passport-size photographs, and resumes.

04

Depending on the profile/requirements laid out by the respective company, a detailed resume should be prepared attractively and submitted within the deadline. Late submissions will not be considered for the test/interview.

05

The details of the resume have to be genuine, in case anyone is found violating this rule strict action related to prohibition to apply for the placements for the rest of the academic year.

06

The placement facility is available to all the students registered with the Corporate Resource Department (CRD) cell through the policy of matching one job to one student at the first instance. This ensures that every student gets equal job opportunities.

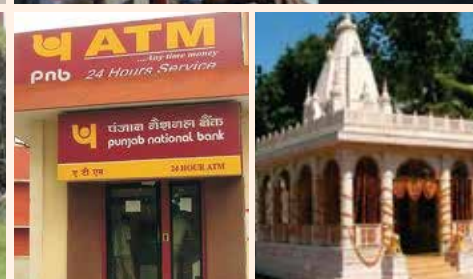

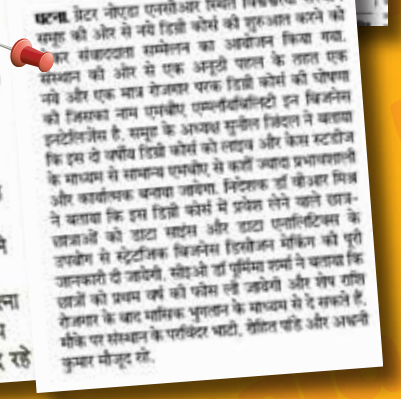

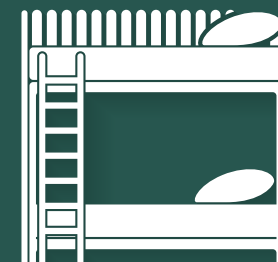
# CAMPUS RULES AND REGULATIONS

Vishveshwarya Group of Institutions believes day scholars are equally important as compared with hostellers and believes in providing facilities available in the campus to them as well.

1. Institute Timings : 10:00 AM to 5:30 PM
2. Institute timings for day scholars are displayed on Institute notice boards, main gate, cafeteria, near auditorium and all prominent locations of the institute. The day scholars are expected to strictly adhere to these timings.
3. The classes will end by 4:50 PM and all day scholar students are suggested/advised to leave the institute latest by 5:05 PM.
4. In between the academic hours, lunch break will be there Students may visit canteen, cafeterias, grounds etc. in the premises during this duration.
5. Student may visit Institute knowledge resource central (library) during academic hours if they do not have lectures or labs.
6. ID Card is provided to each student with his/her Name, Photo, Address. Wearing ID Cards is mandatory while students are in the campus.
7. Dress Code : All the students in the campus should be neatly dressed according to the Institute's guideline - on all days including during all Examinations.

## General Rules

8. NO day scholar student is permitted to visit/ stay in the VGI hostel/Mess.
9. Any visitor accompanying the student is not permitted to visit the campus without prior permission from the respective authorities of the institute
10. Spitting, smoking and throwing bits of paper inside the institute campus are harmful and must be avoided. Students must keep the campus clean by properly using dustbins and should avoid spitting or throwing items in the open spaces in the campus.
11. Students are strictly advised to refrain themselves from possessing, consuming, or distributing alcohol, harmful drugs, narcotics, gutka, cigarette or any other substance causing serious or substantial impact on health. Any violation of these orders will lead to disciplinary action.
12. Students must not possess firecrackers /explosive/flammable materials or spread coloured powder and splash colour water in the pretext of festivals and functions on or during any other occasion in the college campus.
13. Students are advised not to harm the reputation of the institute or individual (fellow students and institute staff) through social and electronic media.



# HOSTEL RULES AND REGULATIONS

All the students who are staying in the hostel are required to follow the following rules and regulations of the hostel

1. New students report to the Hostel Allotment Authority for room allocation upon registration and payment of hostel fees. Allocation is at the discretion of the Chief Warden, contingent on the student's agreement to adhere to hostel rules. The authority may refuse or revoke hostel facilities without explanation for disciplinary reasons. Students may be required to vacate rooms promptly for disciplinary or administrative reasons. Failure to comply may result in the removal of belongings by hostel management, with no liability for breakage or loss.
2. Ragging, both on and off-campus, is strictly prohibited at VGI. The defaulter will face immediate and strict action, including suspension or withdrawal from the hostel/institution. Guidelines from the Ministry of HRD, Government of India, will be adhered to for punishment. Instances of ragging must be reported promptly to the competent authority.
3. New students must report to the Hostel Warden and complete formalities before accessing their allotted rooms.
4. Upon room occupation, students must inspect furniture, fixtures, and fittings, signing a receipt. Any loss or damage will incur charges and possible disciplinary action.
5. Students are responsible for securing their belongings with good quality locks and avoiding leaving valuables unattended, even briefly.
6. Students must register at least one mobile number (of Father/Mother/Guardian) and an email with the Hostel Warden. Permission requests for leaving campus must come from the registered contact.
7. Smoking, alcohol, drugs, and hookah are strictly prohibited on campus. Violations result in severe penalties, including possible expulsion from the hostel or institution. off-campus involvement is treated equally upon entering the campus.
8. Additional electrical appliances such as boilers, hair straighteners, irons, heaters, VCD/DVD players, TVs, VCPs, and VCRs are not allowed in hostel rooms. Violations will result in confiscation and penalties.
9. The warden reserves the right to conduct room inspections in cases of rule violations, suspected unlawful activities, or security risks. This may involve breaking open rooms in the presence of security and another authorized person. Confiscated items will be stored, and any unlawful findings will be dealt with according to the law.
10. All instructions on notice boards are deemed



**read by hostellers.** Non-compliance excuses are not accepted. Students must check notice boards/ websites daily for updates.

11. Report sickness to the warden immediately. If you are unable to leave the room, inform the warden. Notify hostel/institution authorities promptly of any sickness or hospital admission.
12. Visitors, including parents, are not allowed in hostel rooms. Parents/guardians can meet in the visitor's lounge during specified visiting hours with Warden permission.
13. The Warden is available **24/7 via telephone for emergencies.** Numbers are displayed throughout the hostel.
14. Students will incur charges for boarding and lodging beyond the semester at rates set by management.
15. Before longer vacations, students must hand over their room charge, furniture, and fittings to the hostel warden. Failure will result in a room inspection by the Warden/Administrator. The college is not responsible for belongings left in rooms.
16. The warden, accompanied by the student and two other roommates, may inspect belongings. Any **unlawful items found will be confiscated** immediately, with penalties imposed by competent authorities. Disciplinary action may follow if necessary.
17. Violators of the rules will face disciplinary action. The authority's decision is final and binding.
18. Students should not shift room furniture to other place otherwise 1000/- fine will be imposed.
19. Student should take **permission** of hostel warden and principal to **arrange programs** in hostel.

20. **Parents/Guardians/Visitors** can meet their ward in hostel with the permission of the hostel wardens **before 7.00 pm.** No Parent/Guardian/ Visitor is allowed to stay in their room. In girls hostel Male visitors are not allowed to visit students in their living rooms.
21. Students should not write on walls, doors and windows. If found he/she has to face consequences. All residents must keep hostel neat and clean.
22. Students are **not allowed to make union or community** based on caste, religion or region.
23. Students must **follow the mess timings** strictly. If students have any complaints regarding hostel or mess they should immediately inform to the wardens.
24. The Hostel Warden reserves the right to break the lock and open rooms in case of any violation of these rules, suspected unlawful activities or on the basis of perceived security risk.
25. The college reserves the right to shift students from one room to another room for administrative reasons.
26. **Cooking in hostel rooms is not permitted.**
27. Partying in rooms/corridors/anywhere in the hostel is not permitted whatever be the occasion. All students should celebrate parties only in the common area which will be allocated by the University.
28. Hostel residents are advised not to keep large amount of cash, or valuables in the room. The college is not responsible for any loss/ theft of belongings kept in rooms.
29. **Hostel Residents shall not participate in anti national, anti-social, or any undesirable activity**

in or outside the campus. Observing religious rituals in common/public areas is not permitted.

30. Collection of donation for any purpose (religious/ otherwise) is strictly prohibited.

31. Hostel residents are not allowed to put up notices or convene meeting within the hostel premises without written permission of the warden/ assistant warden. Disobedience of this rule will be severely dealt with.

**To ensure a safe and respectful environment, fines will be imposed for various offenses. The fine amounts and punishment which will be penalized and imposed according to the offence committed is listed below:**

Offence	Offence Fine Amount	Remarks
Quarrel and Misbehavior	Rs. 1,00,000/-	He/She will be permanently suspended from Hostel.
Consumption of Alcohol	Rs. 50,000/-	He/She will be permanently suspended from Hostel.
Ganja Smoking/Any other dry intoxication	Rs. 40,000/-	He/She will be permanently suspended from Hostel.
Cigarette Smoking	Rs. 30,000/-	He/She will be suspended from Hostel for 60 days.
Using Induction/Room Heater	Rs. 20,000/-	He/She will be suspended from Hostel for 45 days.
Using Iron (Press)	Rs. 15,000/-	He/She will be suspended from Hostel for 30 days.
Using Electric Kettle	Rs. 10,000/-	He/She will be suspended from Hostel for 15 days.
Electric Bulb	Rs. 5,000/-	He/She will be suspended from Hostel for 7 days.



## DISCIPLINE

Each student is expected to maintain a very high order of discipline and show respect to teachers, sta , seniors, and be courteous to fellow students.

1. He/She has to bear the loss or damage of books, computers, furniture or any other belonging of the institute and Hostel, caused by his/her negligence or carelessness.
2. As per the Supreme Court's order, **Ragging is strictly prohibited** in and around the campus and hostel. Any student found indulged in ragging, will be suspended/rusticates and a committee will be formed for further enquiry.
3. **Smoking and intake of alcohol is strictly prohibited** in and around the campus and hostel.
4. Institute may take any disciplinary action against the students including deduction in internal marks, in case of any misconduct or misbehaviour with faculty, sta , seniors and colleagues.
5. The students are instructed to have no association, whenever active or passive with any unlawful organization.
6. **Gambling** in any form such as playing cards and betting on games is **prohibited**.

## DIRECTION FOR THE STUDENT

1. The fee or registration fee once paid will not be refundable or adjustable in any case.
2. The students are required to pay full fee prescribed for the course by the institute and also other fees such as examination fee, etc. Whenever notified by the Institute authorities.
3. The fee is to be paid by Demand Draft or Pay Orders only, favouring "Vishveshwarya Group of Institutions" payable at Ghaziabad. No fee will be accepted by cheque.
4. In case of non payment of any fee by the given date, the students are liable to pay the fine decided by the Institute.
5. In case a student does not pay the fee by due date with fine the management has the right to strike-off his/her name o the institute's roll and the student is left with the option of seeking re-admissin only (if the Management permits).
6. The Caution Money included in the fee will be refunded only after receiving.

  5. Library CardThe caution money will not be paid, in case the original receipt is lost.
7. In case of withdrawal/Cancellation of an admission in the middle of the session/course, only the caution money shall be paid on the completion of that course only on producing the original receipt and all the remaining fees of the course has to be submitted and if already submitted then it will be fortified. (as per supreme court guidelines)
8. Every student shall attend classes regularly.
9. Any article lost or found shall promptly be reported to the office.
10. Irregular attendance, insubordination to teachers, habitual shirking of class work, obscenity of any sort are sufficient grounds for the suspension or the dismissal of a student from the college.
11. Students are advised to follow the announcements on the notice boards.
12. Ragging, teasing, intimidating, harassing, using words of abuse etc. on junior students especially, female students within the campus or outside is a punishable crime under police act and such matters will be immediately reported to the police. Students involved in such acts will be adequately punished.
13. The submission of leave application does not entitle the student to earn attendance for the days of absence.
14. Attendance will be taken at the beginning of each period.
15. A student requiring leave for a day or for a longer period shall make an application in the prescribed form and submit it to the Principal. The application must be countersigned by the guardian and by the class teacher concerned.
